### 1. Check

### 2. Bank Transfer via Online Bill Pay

Online Bill Pay originates from your bank and is sent directly to FTL via a paper check.

- Amount of donation to be transferred
- How often you want it to be transferred (one time, monthly, quarterly, yearly)
